WHAT IS FAIRNESS?

My first point is the CEO of the Chiquita Banana Business, Brian W. Kocher, does not pay his workers enough money to afford enough food, enough water or enough for their bills for the week. Also, these poor, plantation workers only make approximately, (to the nearest hundred) £1100 per year! To add to that, the proper amount his workers should be paid is, (to the nearest hundred) £11,800, that is £10700 less than they should be earning. Additionally, in the UK 1/3 of the bananas are from the fairtrade company so they should be paid even more. Fair trade means that farmers and other people who make or grow products are paid a fair price for their work. If the Chiquita Banana Business was a fair-trade company, then the plantation workers would be paid a fairer salary. This would ensure that they would have enough food for themselves and

their families. Now, some of the workers might barely have enough money to get food for themselves, let alone their family.

In the past, people considered black people as slaves, they did not have the right to vote, and they were frowned upon. Also, women were considered underachievers (were considered to not do anything properly), and women could not vote either.
